Using the IMPORT Feature To Import Client and Assistant Information into a Lobby Registration Report

Overview

This document describes the filing format used for importing Lobby client and assistant information into a registration report using the Texas Ethics Commission Lobby filing application.

Use the import feature to avoid re-typing client and assistant data into the lobby filing application that you have already entered into other software, such as a spreadsheet.

FILE LAYOUT FOR IMPORTING CLIENTS AND ASSISTANTS

Your import file must meet these requirements:

- Files should be in comma-separated value format and the filename should end with a ".csv" extension.
- All records are comma-separated value (CSV) format records.

- Trailing commas **must** be present for each field regardless of whether data is present.
- Double quotes (") may not be embedded in the data.
- Fields may be surrounded by double-quote characters.
- Any fields which contain embedded commas should always be surrounded by doublequotes.
- Double quotes cannot surround the first field.
- Some data must match entries in code tables. These code tables are described below.

It is highly recommended that you double-check imported records to make sure all information was successfully imported and then manually add anything that is missing.

NOTES ABOUT VARIOUS FIELD TYPES

It is important to prevent any fields from containing "leading spaces" (e.g., " Text information" has a leading space before the word Text). The filing application does not remove the leading spaces from the text. Fields with leading spaces can affect how the text appears in your tables in the filing application and how the text renders on the report.

Whereas any field may be surrounded by double-quote characters, it is very important that any fields that actually contain an embedded comma (such as a name or an address) are surrounded by double-quotes.

The total number of characters in a field cannot exceed the length defined for that field.

NAMES

A Name can either be that of an individual or an entity. Record layouts for individual names have four separate fields (Last Name, First Name(s), Prefix/Title and Suffix). Entity Names are stored "as-is" in the nameOrganization field.

When the named is an individual, the parts of the name (Last, First, Title, Suffix) are stored in the appropriate four name fields. Title is used for things such as Mr., Mrs., Hon, Dr., etc. Suffix is for things such as II, III, Jr., Sr., etc. Both Titles and Suffixes must be entered as codes that are listed in the "Name Prefix/Title Codes" and "Name Suffix Codes" tables below. An error message will be generated if you enter a title or suffix that is not an identical match to one in these tables.

Whether a name is stored as an individual (last, first, etc.) or as an entity depends on whether the entityTypeCd for that name has a value of "individual" or "entity", respectively.

Please note that the total number of characters in a name cannot exceed the length defined for that field.

ADDRESSES

Addresses must contain a complete street, city, state, and a ZIP (+4) code. In other words, a complete mailing address must be supplied when address is required.

Records allow for 2 lines of address (in addition to the fields for city, state, and ZIP+4 code). When only one line of address is given, it should be coded in the Address1 field and the Address2 field should be blank.

ZIP CODES & ZIP+4

Zip Codes are defined as a maximum of 10 characters. Zip Codes can be stored as 5-digit, 9-digit, or as 5-digit/hyphen/4-digit values.

DATA FIELD LAYOUT FOR IMPORTING CLIENTS AND ASSISTANTS

The first column is a list of codes indicating whether a field is required for reporting purposes.

Rx	Required field; TEC rejects filing if absent
R	Required field, but TEC accepts filing
Cx	Conditionally Required field; TEC rejects filing if absent; e.g., First Name is required only when entityTypeCd = "individual"
