* If you file your initial lobby registration after January 1, 2010, your first activities report must cover the reporting period beginning January 1 and ending on the last day of the month in which you register (or ending on December 31 if you file annually). For example, if a registrant first registers on June 4, 2010, that registrant's first monthly report (due by July 10, 2010) would cover the period beginning January 1, 2010, and ending June 30, 2010.
