Monday, March 10, 2014	March monthly activities report (all lobbyists filing monthly)	February 1, 2014, <u>or</u> January 1, 2014, if first activities report*	February 28, 2014
Thursday, April 10, 2014	<b>April monthly activities report</b> (all lobbyists filing monthly)	March 1, 2014, <u>or</u> January 1, 2014, if first activities report*	March 31, 2014
Monday, May 12, 2014 Deadline is extended because of weekend.	May monthly activities report (all lobbyists filing monthly)	April 1, 2014, <u>or</u> January 1, 2014, if first activities report*	April 30, 2014
Tuesday, June 10, 2014	<b>June monthly activities report</b> (all lobbyists filing monthly)	May 1, 2014, <u>or</u> January 1, 2014, if first activities report*	May 31, 2014

\* If you file your initial lobby registration after January 1, 2014, your first activities report must cover the reporting period beginning January 1 and ending on the last day of the month in which you register (or ending on December 31 if you file annually). For example, if a registrant first registers on March 4, 2014, that registrant's first monthly report (due by April 10, 2014) would cover the period beginning January 1, 2014, and ending March 31, 2014.

If you are ever confused about the beginning date for a required report, remember this rule for reporting: **There should never be** gaps between reporting periods and there should never be overlaps.

\* If you file your initial lobby registration after January 1, 2014, your first activities report must cover the reporting period beginning January 1 and ending on the last day of the month in which you register (or ending on December 31 if you file annually). For example, if a registrant first registers on March 4, 2014, that registrant's first monthly report (due by April 10, 2014) would cover the period beginning January 1, 2014, and ending March 31, 2014.
