* If you file your initial lobby registration after January 1, 2015, your first activities report must cover the reporting period beginning January 1 and ending on the last day of the month in which you register (or ending on December 31 if you file annually). For example, if a registrant first registers on March 4, 2015, that registrant's first monthly report (due by April 10, 2015) would cover the period beginning January 1, 2015, and ending March 31, 2015. *Electronic reports must be filed by midnight, Central Time Zone, on the night of the filing deadline.*

If you are ever confused about the beginning date for a required report, remember this rule for reporting: **There should never be** gaps between reporting periods and there should never be overlaps.
