For example, if a registrant first registers on March 4, 2016, that registrant's first monthly report (due by April 11, 2016) would cover the period beginning January 1, 2016, and ending March 31, 2016. *Electronic reports must be filed by midnight, Central Time Zone, on the night of the filing deadline.*
