For example, if a registrant first registers on March 4, 2020, that registrant's first monthly report (due by April 10, 2020) would cover the period beginning January 1, 2020, and ending March 31, 2020. *Electronic reports must be filed by midnight, Central Time Zone, on the night of the filing deadline.*

If you are ever confused about the beginning date for a required report, remember this rule for reporting: **There should never be** gaps between reporting periods and there should never be overlaps.
