| Monday, April 12, 2021 Deadline is extended because of weekend. | April monthly activities report (all lobbyists filing monthly) | March 1, 2021, or January 1, 2021, if first activities report* | March 31, 2021 |
| Monday, May 10, 2021 | May monthly activities report (all lobbyists filing monthly) | April 1, 2021, <u>or</u> January 1, 2021, if first activities report* | April 30, 2021 |
| Thursday, June 10, 2021 | June monthly activities report (all lobbyists filing monthly) | May 1, 2021, or January 1, 2021, if first activities report* | May 31, 2021 |

^{*} If you file your initial lobby registration after January 1, 2021, your first activities report must cover the reporting period beginning January 1 and ending on the last day of the month in which you register (or ending on December 31 if you file annually). For example, if a registrant first registers on March 4, 2021, that registrant's first monthly report (due by April 10, 2021) would cover the period beginning January 1, 2021, and ending March 31, 2021. *Electronic reports must be filed by midnight, Central Time Zone, on the night of the filing deadline.*

If you are ever confused about the beginning date for a required report, remember this rule for reporting: **There should never be gaps between reporting periods and there should never be overlaps**.

| Wednesday, November 10, 2021 | November monthly activities report (all lobbyists filing monthly) | October 1, 2021, <u>or</u> January 1, 2021, if first activities report* | October 31, 2021 |
| Friday, December 10, 2021 | December monthly activities report (all lobbyists filing monthly) | November 1, 2021, <u>or</u> January 1, 2021, if first activities report* | November 30, 2021 |
| Monday, January 10, 2022 | January monthly activities report (all lobbyists filing monthly) | December 1, 2021, <u>or</u> January 1, 2021, if first activities report* | December 31, 2021 |
