Tuesday, May 10, 2022	May monthly activities report (all lobbyists filing monthly)	April 1, 2022, <i>or</i> January 1, 2022, if first activities report*	April 30, 2022

* If you file your initial lobby registration after January 1, 2022, your first activities report must cover the reporting period beginning January 1 and ending on the last day of the month in which you register (or ending on December 31 if you file annually). For example, if a registrant first registers on March 4, 2022, that registrant’s first monthly report (due by April 11, 2022, deadline extended because of weekend) would cover the period beginning January 1, 2022, and ending March 31, 2022. ***Electronic reports must be filed by midnight, Central Time Zone, on the night of the filing deadline.***

If you are ever confused about the beginning date for a required report, remember this rule for reporting: **There should never be gaps between reporting periods and there should never be overlaps.**
