

AFFIDAVIT FOR DIRECT CAMPAIGN EXPENDITURE REPORT: ELECTRONIC FILING EXEMPTION - ENTITY

An exemption affidavit must be submitted with each paper report.

Beginning on January 1, 2023, a person not acting in concert with another person who makes one or more direct campaign expenditures that exceed \$150 in an election from the person's own property must file campaign finance reports as if the person were the campaign treasurer of a general purpose political committee. These reports are required to be filed electronically unless the person is eligible to claim the statutory exemption.

Beginning on January 1, 2023, an entity filing a direct campaign expenditure report that has made more than \$30,820 in direct campaign expenditures in <u>any</u> calendar year must file all subsequent reports electronically.
