- 9. AOR-536: The Texas Ethics Commission has been asked to consider whether an incorporated statewide organization with incorporated local chapters may invite legislators and other elected

officials to address the organization's membership regarding the issues of interest to the membership.

- 10. AOR-535: The Texas Ethics Commission has been asked to consider whether the description of a cash or cash equivalent gift of over \$250 that is reportable under section 572.023 (7) of the Government Code is required to include the value of the gift.
- 11. Public discussion and possible action on the proposal and publication in the Texas Register of Ethics Commission Rule § 20.62 (Reporting Staff Reimbursement), regarding the reporting of a political expenditure made out of personal funds by a staff member of either a candidate or political committee.
