#### **MINUTES**

This meeting was tape recorded. These minutes are a summary record of the commission's actions at the meeting. For a detailed record of discussions and statements made by persons speaking at the meeting, please consult the audio tapes on file at the commission's office.

Agenda Item 1: Call to order; roll call.

The meeting was called to order by Vice Chair Harrison. David A. Reisman, Executive Director, called the roll. All commissioners were present except Chair Davenport and Commissioner Montagne.

**Agenda Item 2:** Communication to the commission from the public.

**Agenda Item 3:** Comments by the commissioners.

Vice Chair Harrison presented former Chair Looney with a gavel in appreciation for his service as chair of the commission.

**Agenda Item 4:** Comments by the executive director.

David A. Reisman, Executive Director, made the following comments:

- 1. Texas Ethics Commission staff has been working with the Legislature on bills, answering questions, and providing other assistance as needed.
- 2. Texas Ethics Commission staff is tracking approximately 100 bills that might affect the laws administered by the Ethics Commission. Commissioners received a summary of the bills in their packets. A tracking spreadsheet was distributed to the commissioners that contained asterisk marks on bills that pertained to the

taskforce recommendations. Approximately 30 bills addressed the commission's taskforce recommendations. Staff will continue to answer questions, attend committee hearings, and testify on bills as resource witnesses throughout the session. At the end of session the Texas Ethics Commission will immediately begin to update the guides, software, and website to reflect any changes to laws we administer.

- 3. The Texas Ethics Commission is tracking the budget through the process. The House and Senate budget bills have both passed and now will go to Conference Committee. Staff will also serve as a resource in that process by answering questions on our commission and our needs to the Legislature. Mr. Reisman will advise the commissioners of the result of the budget recommendations once complete.
- 4. Included in the commissioners' packets are the internal staff guidelines for penalties, including relevant laws and commission rules and the statutorily set fines.
- 5. Mr. Reisman introduced Cherri Phelps, administrative assistant in the Disclosure Filing Section, and Sandra Smith, Director of Administration/Chief Financial Officer. The Texas Ethics Commission currently has an Attorney I position posted on our website.
- 6. This calendar year, 45 sworn complaints have been received.
- 7. Mr. Reisman reminded the commissioners that personal financial statements are due by April 30, 2007, unless an extension to June 29, 2007, is requested.
- 8. Mr. Reisman expressed his appreciation to the Texas Workforce Commission for the use of their conference room.
