MINUTES

This meeting was recorded. These minutes are a summary record of the Commission's actions at the meeting. For a detailed record of discussions and statements made by persons speaking at the meeting, please consult the audio recordings on file at the Commission's office.

Agenda Item 1: Call to order; roll call.

The meeting was called to order by Chair Mendoza. David A. Reisman, Executive Director, called the roll. All Commissioners were present, except Vice Chair Graham.

Agenda Item 2: Communication to the Commission from the public.

None.

Agenda Item 3: Comments by the Commissioners.

Chair Mendoza stated that this was her last meeting as Chair of the Ethics Commission, but she will continue as Commissioner. She thanked the Commission for their support. Chair Mendoza spoke regarding the decorum on speaking before the Commission.

Agenda Item 4: Comments by the executive director.

David A. Reisman, Executive Director, made the following comments:

- 1. Mr. Reisman discussed the legislative appropriations request and the effects of the budget cuts on the Commission. He also discussed the changes made within the agency.
- 2. Mr. Reisman stated that 424 sworn complaints had been filed as of December 6, 2010. In 2008, the Commission had 388 sworn complaints filed, the most in any year until 2010. He stated that due to workload increases, the time to process sworn complaints would increase.

3. Mr. Reisman stated that services of the Commission would be steamlined; however, there would probably be a reduction in customer services to the regulated community.

Chair Mendoza stated that the nominating committee named Vice Chair Jim Graham for Chair and Commissioner Wilhelmina Delco for Vice Chair. Motion by Commissioner Harrison to appoint Vice Chair Graham as Chair and Commissioner Delco as Vice Chair; second by Commissioner Henderson. Motion passed by a vote of seven ayes.
