#### **MINUTES**

Agenda Item 1: Call to order; roll call.

The meeting was called to order by Chair Graham. David A. Reisman, Executive Director, called the roll. All Commissioners were present.

David A. Reisman, Executive Director, made the following comments:

1. Mr. Reisman stated that Ginger Hunter, Assistant General Counsel, had recently resigned and left to work for another state agency. He said that we were sorry to see her go and that she did a great job.

- 2. Mr. Reisman stated that Jessie Haug, Computer Services Director, started a few months ago and has been doing a great job. There are a lot of big and new projects that have to be implemented. Her computer services staff has been busy working on these.
- 3. Mr. Reisman discussed the upcoming Council on Governmental Ethics Laws (COGEL) Conference scheduled for the week of December 5th. He stated that he was on the steering committee.
- 4. Mr. Reisman discussed the quarterly report. He stated that there are 33 FTE's, less employees due to budget reductions. Mr. Reisman stated that expenditure totals were \$1.9m and the Commission had spent less in FY2011 than in FY 2010. He thanked Mike McElhaney, CFO. He kept right above the levels all year long without any problems with all the reductions and spending issues. Mr Reisman stated that he looks forward to doing the same thing in the next biennium.
- 5. Mr. Reisman discussed the sworn complaint filings for FY2011. He stated that 374 had been filed, tying the record for FY2010. Mr. Reisman discussed the sworn complaint charts he had prepared.
- 6. Mr. Reisman discussed the Sunset review. He stated that the Commission had met this week with the Sunset Commission. The Sunset review will be starting soon and the Ethics Commission will be working with the Sunset Commission over the next few months.
- 7. Mr. Reisman discussed updates to the Ethic Commission's campaign finance training video that is on the website. He stated that there were many legislative changes and that the agency has updated the guides, website, and campaign finance video. Mr. Reisman wanted to thank the Speaker's Office and the House for their work on the campaign finance video.

# Agenda Item 5: Report on trip to Honduras to meet with U. S. State Department and Honduran government officials on governmental anti-corruption efforts by Natalia Luna Ashley, General Counsel.

Natalia Luna Ashley presented this agenda item. On September 7, 2011, through September 10, 2011, Ms. Ashley participated in the U. S. State Department's speaker and specialist program which was held in the capital of Honduras. Ms. Ashley spoke at a conference and to university students. She participated in round table discussions, was one of three panelists on a live radio show, met with a member of congress, and attended working dinners. The main topic was anti-corruption issues in government and the meetings were conducted in Spanish.
