MINUTES

This meeting was recorded. These minutes are a summary record of the Commission's actions at the meeting. For a detailed record of discussions and statements made by persons speaking at the meeting, please consult the audio recordings on file at the Commission's office.

Agenda Item 1: Call to order; roll call.

The meeting was called to order by Chair Ramsay. David A. Reisman, Executive Director, called the roll. All Commissioners were present.

Agenda Item 2: Communication to the Commission from the public.

None.

Agenda Item 3: Comments by the Commissioners.

None.

Agenda Item 4: Comments by the executive director.

David A. Reisman, Executive Director, made the following comments:

1. Mr. Reisman discussed the quarterly report. He stated that 275 complaints have been filed this fiscal year. Mr. Reisman also stated that since January 1st, 192 complaints have been filed and that there are 239 pending sworn complaints.

- 2. Mr. Reisman discussed the Strategic Plan and Budget. He stated the Ethics Commission is working with the Legislative Budget Board (LBB) and the Governor's Office on the Strategic Plan and Budget. Mr. Reisman discussed the customer survey and stated that two years ago the overall approval rate for the Commission was 90.5% and that this year's results increased to 93%. He stated that the next issue was the budget structure and that he had asked the LBB and Governor's Office to relook at the budget structure. Mr. Reisman discussed a chart that he had prepared that shows the previous budget structure and the current budget structure that was approved by the LBB and the Governor's Office. He stated that the next step was to prepare the budget and submit it to the Legislature. Mr. Reisman stated that the Strategic Plan and Budget report is due August 9, 2012, and that he would ask for two exceptional items \$100,000 for each year to reach a salary equity and an increase for a technology fund.
- 3. Mr. Reisman stated that Susana Esparza, Assistant General Counsel, left the agency to work for the Texas Department of Agriculture. He also stated that the Commission had hired Brad Johnson back from the private sector. Mr. Reisman announced the promotion of Tim Sorrells, Deputy General Counsel, to General Counsel. He also announced the promotion of Natalia Luna Ashley, General Counsel, to Special Counsel.
- 4. Commissioner Hobby discussed the issue of redirecting responsibilities of the agency and placing more effort toward enforcement. Commissioner Untermeyer stated that he agreed with Commissioner Hobby to redirect resources regarding sworn complaints. Natalia Luna Ashley stated that the Commission needed to set an agenda item for this at the next Commission meeting. Commissioner Mendoza then stated that a task force should be formed to discuss this issue. Chair Ramsay formed a task force consisting of himself along with Commissioners Mendoza, Harrison, and Untermeyer.

Agenda Item 5: Approve minutes of the April 18, 2012, Executive Session and the April 18, 2012, Commission meeting.

Motion by Commissioner Long to adopt the minutes of the April 18, 2012, Executive Session and the April 18, 2012, Commission meeting, second by Commissioner Mendoza. **Motion passed by a vote of eight ayes.**

Agenda Item 6: Discussion and possible action on Sunset Advisory Commission decisions.

David A. Reisman, Executive Director, presented this agenda item. Mr. Reisman stated that the hearing was held on June 5, 2012. He discussed the decisions made by the Sunset Advisory Commission as compared to the Sunset Commission staff decisions. He thanked the Commissioners that attended the hearing – Vice Chair Clancy, and Commissioners Harrison and Long. Mr. Reisman stated that from those decisions made by the Sunset Advisory Commission, the issues will be laid out in a Sunset bill, and then the bill would go through the legislative process at the next legislative session.

Agenda Item 7: Discussion and possible action on the reporting requirements, filing and posting of personal financial statements.

Vice Chair Jim Clancy presented this agenda item. He stated that the personal financial statement (PFS) form did not fill its purpose, that the interest now would be in the sources of income, assets and liabilities. He also stated that the PFS should be a check on any conflicts of interest in public service and not be a barrier to entry. Vice Chair Clancy was concerned with public trust. He wanted to know what could be done to fix parts of the form now and then how to fix the rest of it later. Natalia Luna Ashley stated that the PFS form elicits the information that is set out in statute, section 572.032 of the Government Code. She stated that changing the form would require legislative action.

Vice Chair Clancy asked if the PFS could track the federal tax return. Ms. Ashley stated that the tax return did not contain all the information needed in the PFS form by statute. Commissioner Hobby stated that the PFS form was not useful for its intended purpose, that filers could submit bank statements. Commissioner Mendoza stated that it would be difficult from an operational or staff perspective by using tax returns or bank statements, that it would be easier to look at the PFS form. David A. Reisman stated that the Sunset Advisory Commission recommended that the PFS be filed electronically. He also stated that the form would be uniform and efficient, and that the public would find it difficult to view tax returns and bank statements.

Commissioner Untermeyer asked what constituted a financial conflict of interest. He suggested that the legislature set an arbitrary percentage that a holding constitutes above a certain level that would have to be reported.

Vice Chair Clancy asked what Ethics Commission rules govern the PFS. Ms. Ashley stated that there were advisory opinions on the matter and that statutes provide the ranges. She also stated that by Commission rule the PFS must be filed on a form adopted by the Commission.

Vice Chair Clancy then asked if the Commission could make the PFS part of the legislative recommendations.

Craig McDonald, Director, Texans for Public Justice, spoke before the Commission. He discussed recommendations from his hand-out regarding updates and reforms. Mr. McDonald suggested that the PFS should be submitted electronically. He also suggested that the outcome should be in a database format to make it easier to search. He further suggested that there be a reasonable threshold for reporting and that all forms of income should be reported. Mr. McDonald then suggested that PFS reports be made available on-line.

Vice Chair Clancy stated that since assets listed typically in the PFS do not change much from year to year, a form could be used that states what has changed from the prior year.
