#### **MINUTES**

This meeting was recorded. These minutes are a summary record of the Commission's actions at the meeting. For a detailed record of discussions and statements made by persons speaking at the meeting, please consult the audio recordings on file at the Commission's office.

#### Agenda Item 1: Call to order; roll call.

The meeting was called to order by Chair Hobby. Natalia Luna Ashley, Executive Director, called the roll. All Commissioners were present. Chair Hobby reported on the progress of the electronic filing software project. The start date was moved to April 28, 2015, because of several elections. The Commission passed a motion during the Workshop Session that gives filers with a May 5, 2015, non-critical filing deadline a 30-day grace period; any critical reports will be reviewed on a case-by-case basis.

#### **Agenda Item 2:** Communication to the Commission from the public.

Tony McDonald, General Counsel for Empower Texans; Jack Gullahorn, representing Professional Advocacy Association of Texas; Steve Bresnen; Trey Trainor, representing Texas Right to Life; and Joseph M. Nixon, representing Empower Texans, Inc.; each spoke separately before the Commission.

Before Agenda Item 3, Chair Hobby exercised Chair's privilege and addressed the Commission. Chair Hobby spoke about the new Electronic Filing Application, which now has a live date of April 28, 2015. The release date is later than originally anticipated because of a special and runoff election. Chair Hobby reiterated that non-critical reports that are due on May 5, 2015, will get a grace period of one month; non-critical reports that are involved in an election cycle will be considered on a case-by-case basis.

Commissioner Clancy began discussion on this agenda item. Chair Hobby, Vice Chair Untermeyer, and Commissioners Akin, Clancy, Harrison, Long and Ramsay had comments on this item. Joe Nixon and Trey Trainor spoke before the Commission on this item. No action was taken.

Agenda Item 5: Briefing and discussion of ethics legislation in the 2015 legislative session, including status of Ethics Commission legislative recommendations.

Natalia Luna Ashley, Executive Director, briefed the Commission on this agenda item. The Commission is tracking approximately 80 bills. Sixteen of the 24 statutory changes recommended by the Commission in December 2014 have been addressed in seven bills. Vice Chair Untermeyer requested information on the status of the Commission's budget in both the House and the Senate; Ms. Ashley responded.

Agenda Item 6: Discussion of Opinion Request AOR-594: Whether a communication relating to a measure election complies with section 255.003 of the Election Code.

Ian Steusloff, Assistant General Counsel, briefed the Commission on this item. Commissioner Harrison made a motion to adopt AOR-594 with no changes; second by Commissioner Akin. Motion passed by eight ayes. **AOR-594 is adopted.** 

Agenda Item 7: Public discussion and possible action on the adoption or proposal and publication in the Texas Register of an amendment to Texas Ethics Commission Rules § 6.5 (Authority to Adopt Rules) relating to the Commission's authority to adopt rules.

Natalia Luna Ashley, Executive Director, briefed the Commission on this agenda item. Motion by Commissioner Akin to adopt the amendment to Texas Ethics Commission Rules § 6.5 (Authority to Adopt Rules); second by Commissioner Harrison. **Motion passed by a vote of eight ayes**.

Agenda Item 8: Public discussion and

Natalia Luna Ashley, Executive Director, briefed the Commission on this agenda item. Ms. Ashley outlined three options available to the Commissioners. Brad Johnson spoke before the Commission on this item. Motion by Commissioner Clancy to publish the amendment to Texas Ethics Commission Rules § 20.59 (Reporting Expenditure by Credit Card) in the Texas Register for public comment, using Option 1, with one change in subsection (b) to change "an expenditure" to "a payment"; second by Commission Akin. Motion passed by a vote of eight ayes.

Agenda Item 9: Public discussion and possible action on the proposal and publication in the Texas

register of an amendment to Section 251.001(7) of the Election Code regarding the

definition of campaign expenditure.

Commissioner Harrison was off the dais during a portion of Agenda Item 13.

Ian Steusloff, Assistant General Counsel, briefed the Commission on this agenda item. Motion by Vice Chair Untermeyer to publish in the Texas Register for public comment an amendment to Texas Ethics Commission Rules § 20.1 (definition of "in Connection with a Campaign"), which clarifies Texas Election Code § 251.001(7) (definition of campaign expenditure) in the Texas Register for public comment; second by Commissioner Delco. **Motion passed by a vote of eight ayes**.
