MINUTES

Agenda Item 1: Call to order; roll call.

The meeting was called to order by Chair Hobby. Natalia Luna Ashley, Executive Director, called the roll. All Commissioners except Commissioner Delco were present.

Agenda Item 2: Communication to the Commission from the public.

Joe Nixon, representing Empower Texans, Inc., and Trey Trainor, representing Jim Graham and Texas Right to Life Committee, Inc., spoke before the Commission. Mr. Trainor gave the Commission a handout.

Agenda Item 3: Comments by Commissioners.

None.

Agenda Item 4: Approve minutes for the following meetings:

Motion by Vice Chair Untermeyer to approve the meeting minutes listed under Agenda Item 4; second by Commissioner Long. **Motion passed by a vote of seven ayes.**

Agenda Item 5: Briefing, discussion and possible action on the new Electronic Filing Application, including status of Lobby and Personal Financial Statement applications and making the campaign finance code available to Texas political subdivisions.

Natalia Luna Ashley, Executive Director, and Jessie Haug, Director of Computer Services, briefed the Commission on this agenda item. Leticia Vasek, City Clerk for the City of San Antonio, spoke before the Commission, and gave the Commission a handout. Ms. Ashley commented that the electronic filing of the July semiannual campaign finance reports went well. Ms. Haug commented that the mobile application became available about two weeks ago; the Lobby application will be available on August 20, 2015. The Commission has been approached by several cities for permission to use the code for its filing application. The Commission is not prepared to share or sell this code at this time. Chair Hobby and Commissioner Clancy responded with questions and comments. No action was taken.

Chair Hobby and Commissioner Ramsay left the dais briefly during Agenda Item 6.

Agenda Item 6: Discussion and possible action on rules and form required to be adopted by the Commission in accordance with House Bill 1295, 84th Legislative Session, 2015.

Chair Hobby and Commissioner Clancy briefed the Commission on this agenda item. Sedora Jefferson, Associate Executive Director and General Counsel of the Texas Association of School Boards; Katy Aldridge from Rep. Giovanni Capriglione's office gave the Commission a handout; Chris Howell; Donald Lee, Executive Director of the Texas Conference of Urban Counties; and Mark Mendez, Assistant County Administrator of Tarrant County spoke before the Commission. Chair Hobby, Vice Chair Untermeyer and Commissioners Akin, Clancy and Harrison responded with questions and comments. Motion by Commissioner Ramsay to appoint a subcommittee (including Commissioner Clancy (Chair), Vice Chair Untermeyer and Commissioner Harrison) to study this agenda item and report back to the full Commission at the next meeting; second by Commissioner Long. **Motion passed by a vote of seven ayes.**

Agenda Item 7: Discussion and possible action on a form required to be adopted by the Commission in accordance with House Bill 23, 84th Legislative Session, 2015.

Chair Hobby and Natalia Luna Ashley, Executive Director, briefed the Commission on this agenda item. Vice Chair Untermeyer and Commissioner Long responded with questions and comments. Motion by Commissioner Harrison to approve the changes to Forms CIQ and CIS; second by Commissioner Long. **Motion passed by a vote of seven ayes.**

Agenda Item 8: Public discussion and possible action on a clarification of Texas Ethics Commission Rules § 34.5, relating to lobby registration requirements.

Ian M. Steusloff, General Counsel, briefed the Commission on this agenda item. Jack Gullahorn, representing himself and the Professional Advocacy Association of Texas, spoke before the Commission. Chair Hobby, Vice Chair Untermeyer and Commissioners Harrison and Ramsay responded with questions and comments. Motion by Vice Chair Untermeyer to publish for public comment the changes to Texas Ethics Commission Rule § 34.5, as amended; second by Commissioner Harrison. **Motion passed by a vote of seven ayes.**

For the remaining Agenda Items 9 through 21, the following represents the actions taken by the Commission in the order they occurred during the meeting.

Agenda Item 13: Discussion of Advisory Opinion No. SP 12: Regarding whether a person appointed to the Cancer Prevention and Research Institute of Texas Oversight Committee is an "appointed officer" for purposes of Chapter 572 of the Government Code.

Chair Hobby briefed the Commission on this agenda item. Kristen Doyle, General Counsel and Deputy Executive Officer of the Cancer Prevention and Research Institute of Texas, spoke before the Commission. Chair Hobby responded with questions. Motion by Vice Chair Untermeyer to adopt Advisory Opinion No. SP-12 with no changes; second by Commissioner Long. Motion passed by a vote of seven ayes. **SP-12 is adopted.**

Chair Hobby, Vice Chair Untermeyer, Commissioner Harrison and Natalia Luna Ashley, Executive Director, responded with questions and comments. Motion by Vice Chair Untermeyer to publish both options for public comment, as amended; second by Commissioner Harrison. **Motion passed by a vote of six ayes.**

Commissioner Ramsay returned to the dais during discussion on Agenda Item 9.

Agenda Item 9: Public discussion and possible action on the adoption or proposal and publication in the Texas Register of an amendment to Texas Ethics Commission Rules § 20.1 (Definitions), adding a definition for "In connection with a Campaign", for purposes of Election Code

§ 251.001(7), relating to the definition of campaign expenditure.

Commissioner Clancy continued his briefing to the Commission on this agenda item. Vice Chair Untermeyer, Commissioner Clancy and Natalia Luna Ashley, Executive Director, responded with questions and comments. Motion by Commissioner Clancy to republish the rule for public comment, as amended; second by Vice Chair Untermeyer. **Motion passed by a vote of seven ayes**.

Agenda Item 12: Discussion of Advisory Opinion Request No. AOR-600: Regarding the legislative advertising disclosure requirements for legislative advertising that is broadcast pursuant to a contract personally signed by an individual on behalf of a corporation.

Ian M. Steusloff, General Counsel, briefed the Commission on this agenda item. Chair Hobby responded with questions and comments. Motion by Commissioner Ramsay to adopt AOR-600 with no changes; second by Vice Chair Untermeyer. Motion passed by a vote of seven ayes. **AOR-600** is **adopted.**
