#### **MINUTES**

This meeting was recorded. These minutes are a summary record of the Commission's actions at the meeting. For a detailed record of discussions and statements made by persons speaking at the meeting, please consult the audio recordings on file at the Commission's office.

#### Agenda Item 1: Call to order; roll call.

The meeting was called to order by Chair Hobby. Natalia Luna Ashley, Executive Director, called the roll. All Commissioners were present except Commissioner Harrison.

#### **Agenda Item 2:** Comments by the Commissioners.

Commissioner Clancy commented that House Bill 1295 from the 84<sup>th</sup> Legislature was the strongest ethics law in the last 20 years, but there are limitations on what the Commission can do. It will require some tweaks by the Legislature in the future. Chair Hobby commented that the Commission had debuted three separate disclosure modules during his tenure as Chair. The new Chair will handle a possible change in the Personal Financial Statement (PFS) module, regarding disclosing the address of the source of dividends. Chair Hobby discussed the *Van Hollen v. FEC* case.

### **Agenda Item 25:** Comments by the Executive Director.

Natalia Luna Ashley, Executive Director, addressed the Commission. Eight-eight new Sworn Complaints were filed since the last Commission meeting. A new search engine was created for Form 1295's. Over 17,000 Form 1295's have been filed so far this year. The Commission received approximately 700 calls on HB 1295 in February, and approximately 600 calls in March. The Commission is studying the trend of the questions to create Frequently Asked Questions for the regulated community. Telephone calls to the Commission as an agency, including legal and technical support, totaled over 27,000 for January and over 28,000 for February; this is partly because there are a lot of new people in the system using the electronic filing applications for the first time. A query feature was added to the Simple Search on the Commission's website that allows users to find all reports, including corrections, or only the most recent corrected reports. The next all-day training symposium will be held on Friday, July 8, 2016, in Lewisville, at the MCL Grand Theater; there is plenty of free parking. Ms. Ashley thanked the staff for all of their hard work, and thanked Chair Hobby for his leadership.
