MINUTES

Agenda Item 1: Call to order; roll call.

The meeting was called to order by Chair Untermeyer. Seana Willing, Executive Director, called the roll. All Commissioners were present except Commissioners Delco, Kennedy and Ramsay. Chair Untermeyer and Vice Chair Wolens addressed the Commission.

Agenda Item 2: Comments by the Executive Director.

Seana Willing, Executive Director, addressed the Commission. She thanked Ian Steusloff, General Counsel, for his work as Interim Executive Director. Ms. Willing attended the Senate Finance Hearing on February 6, 2017, with Commissioner Clancy. The Ethics Commission is scheduled before House Appropriations on February 22, 2017. There will be follow-up questions by the Legislative Budget Board on exceptional items. Vice Chair Wolens asked Chair Untermeyer if he would be attending the February 22, 2017, hearing; Chair Untermeyer said that he planned to attend. Commissioner Clancy addressed the Commission on the current version of the budget and the Commission's exceptional items.
