Agenda Item 1: Call to order; roll call.

The meeting was called to order by Chair Untermeyer. All Commissioners were present.

Agenda Item 2: Contested Case Proceeding: Sworn Complaint No. SC-31404104 and Sworn Complaint No. SC-31405130, In the Matter of Sid Miller, Respondent. Prehearing conference.

James Tinley, Assistant General Counsel, briefed the Commission on Sworn Complaint No. SC-31404104. Mr. Tinley stated that he and Mr. Joseph M. Nixon, attorney for Respondent Sid Miller, were able to reach a tentative settlement agreement, where Respondent would pay a \$250 fine, file all needed corrections to his reports as consistent with the Order, and agree to the Findings of Fact and Stipulations of Law, as shown on pages "MILLER1 0157" through "MILLER1 0164." Mr. Nixon agreed.

James Tinley, Assistant General Counsel, briefed the Commission on Sworn Complaint No. SC-31405130. Mr. Tinley stated that he and Mr. Joseph M. Nixon, attorney for Respondent Sid Miller, were able to reach a tentative settlement agreement, where Respondent would pay a \$2,500 fine, file all needed corrections to his reports as consistent with the Order, and agree to the Findings of Fact and Stipulations of Law, as shown on pages "MILLER2 0122" through "MILLER2 0129." Mr. Nixon agreed.

Mr. Nixon agreed.

Vice Chair Wolens announced that the Commissioners had agreed by unanimous consent to the settlement of Sworn Complaint No. SC-31405130 under the following terms: Respondent would pay a \$2,500 fine, file all needed corrections to his reports as consistent with the Order, and agree to the Findings of Fact and Stipulations of Law, as shown on pages "MILLER2 0122" through "MILLER2 0129," except for paragraph VII, all to be completed by June 15, 2017. Mr. Nixon agreed.

Vice Chair Wolens returned the chairing of the meeting back to Chair Untermeyer.
