The meeting was called to order by Chair Wolens. Seana Willing, Executive Director, called the roll. All Commissioners were present.

may request businesses to offer or confer a deal or discount to a person merely because that person has voted, and whether the candidate may create and

distribute fliers advertising such a deal or discount.

Public discussion and possible action on the adoption or proposal and publication in the Texas Register of an amendment to Ethics Commission Rules § 6.1 and new Ethics Commission rules §§ 27.1 and 27.101, regarding when a declaration of intent (JDI) is required to for judicial candidates.

Chair Wolens briefed the Commission on this agenda item. Commissioner Kennedy responded with comments. Motion by Commissioner Kennedy to adopt an amendment to Ethics Commission Rules § 6.1 and new Ethics Commission Rules § 27.1 and 27.101; second by Commissioner Erben. **Motion passed by a vote of eight ayes.** 

# **Agenda Item 10:**

Public discussion and possible action on the adoption or proposal and publication in the Texas Register of new Ethics Commission Rules §§ 12.31 and 12.33, regarding decorum and sanctions in sworn complaint proceedings.

Chair Wolens briefed the Commission on this agenda item. Commissioners Kennedy and Ramsay, and Ian Steusloff, General Counsel, responded with questions and comments. Motion by Commissioner Ramsay to republish new Ethics Commission Rules §§ 12.31 and 12.33 in the Texas Register for public comment, as amended; second by Commissioner Slovacek. **Motion passed by a vote of eight ayes.**

#### **Agenda Item 12:**

Public discussion and possible action on the adoption or proposal and publication in the Texas Register of an amendment to Ethics Commission Rules § 20.33, regarding the authority of the Commission or local filing authority to terminate an inactive filer's campaign treasurer appointment.

Chair Wolens briefed the Commission on this agenda item. Motion by Commissioner Ramsay to adopt an amendment to Ethics Commission Rules § 20.33; second by Commissioner Slovacek. **Motion passed by a vote of eight ayes.** 

## **Agenda Item 13:**

Public discussion and possible action on the adoption or proposal and publication in the Texas Register of new Ethics Commission Rules § 12.36 (Assessment of Civil Penalty) and a repeal of Ethics Commission Rules § 18.27 (Sworn Complaints), clarifying the facts that the Commission will consider when assessing a civil penalty in the complaint process.

Chair Wolens briefed the Commission on this agenda item. Motion by Vice Chair Craycraft to adopt new

Ethics Commission Rules § 12.36 and repeal Ethics Commission Rules § 18.27; second by Commissioner Kennedy. **Motion passed by a vote of eight ayes.** 

Agenda Item 14: Public discussion and possible action on the adoption or proposal and publication in the Texas Register of an amendment to Ethics Commission Rules § 12.87 (Resolution of Preliminary Review Hearing), regarding procedures for preliminary review hearings.

Chair Wolens briefed the Commission on this agenda item. Motion by Commissioner Clancy to adopt an amendment to Ethics Commission Rules § 12.87; second by Commissioner Erben. **Motion passed by a vote of eight ayes.** 

Agenda Item 15: Public discussion and possible action on the proposal and publication in the Texas Register of amendments to Ethics Commission Rules §§ 6.7, 12.53, 12.81, 12.83 and 12.84, and new Ethics Commission Rules § 12.82, regarding communications between commission staff and members.

Ian Steusloff, General Counsel, briefed the Commission on this agenda item. Chair Wolens, Commissioners Clancy, Flood and Slovacek, Seana Willing, Executive Director, and Mr. Steusloff responded with questions and comments. Motion by Commissioner Flood to publish Option Two of the drafts provided, including amendments to Ethics Commission Rules §§ 12.53 and 12.83 in the Texas Register for public comment; second by Commissioner Clancy. **Motion passed by a vote of eight ayes.** 

Agenda Item 16: Public discussion and possible action on the proposal and publication in the Texas Register of an amendment to Ethics Commission Rules § 26.1, regarding political advertising on the Internet.

Chair Wolens briefed the Commission on this agenda item. Motion by Commissioner Kennedy to publish an amendment to Ethics Commission Rules §§ 26.1 in the Texas Register for public comment; second by Commissioner Ramsay. **Motion passed by a vote of eight ayes.** 

Agenda Item 17: Public discussion and possible action on the proposal and publication in the Texas Register of an amendment to Ethics Commission Rules § 12.13, regarding non-resident attorneys appearing before the commission.

Ian Steusloff, General Counsel, briefed the Commission on this agenda item. Chair Wolens, Commissioners Clancy, Flood, Kennedy and Slovacek, and James Tinley, Assistant General Counsel, responded with questions and comments. Motion by Commissioner Slovacek to publish an amendment to Ethics Commission Rules § 12.13 in the Texas Register for public comment, as amended; second by Commissioner Ramsay. **Motion passed by a vote of eight ayes.** 

Agenda Item 18: Public discussion and possible action on the proposal and publication in the Texas Register of an amendment to Ethics Commission Rules § 18.7, regarding the late filing of a report when the Commission's office is closed.

Motion by Commissioner Slovacek to publish new Ethics Commission Rules §§ 12.101, 12.102, 12.121, 12.123, 12.125, 12.127, 12.131, 12.133, 12.151, 12.153, 12.155, 12.161, 12.163, 12.165, 12.167, 12.171, 12.173, and 12.175 in the Texas Register for public comment; second by Commissioner Kennedy. **Motion passed by a vote of eight ayes.** 

Agenda Item 20: Public discussion and possible action on the proposal and publication in the Texas Register of new Ethics Commission Rules Chapter 16 (Facial Compliance Review & Full Audits), including §§ 16.1 – 16.11, regarding procedures for facial compliance reviews and audits.

Ian Steusloff, General Counsel, briefed the Commission on this agenda item. Chair Wolens and Commissioners Kennedy and Slovacek responded with questions and comments. No action was taken.

Agenda Item 21: Discussion of possible recommendations for statutory changes to the 86th Legislature as required by § 571.073 of the Government Code.

Ian Steusloff, General Counsel, briefed the Commission on this agenda item. Chair Wolens and Commissioner Slovacek responded with questions and comments. No action was taken.
