Discussion and possible action on the adoption or proposal and publication in the Texas Register of the repeal of Ethics Commission Rules §22.5, regarding corporate and labor organization contributions to direct campaign expenditure committees, and amendments to Ethics Commission Rules §§20.1 and 22.6 regarding definitions of terms in Title 15 of the Election Code that are in conflict with or made obsolete by, legislation passed in the 86th Legislative Session.
