### §22.37. Virtual Currency Contributions. Text of Proposed New Rule

## 1 Chapter 22. RESTRICTIONS ON CONTRIBUTIONS AND EXPENDITURES

## 2 <u>§22.37. Virtual Currency Contributions.</u>

- 3 (a) Candidates, officeholders, political committees, and legislative caucuses may accept virtual
  4 currency contributions.
- 5 (b) Virtual currency contributions are considered "in-kind" contributions.
- 6 (c) A candidate, officeholder, or political committee must report a gain from the sale of virtual
- 7 currency contributions on the appropriate schedule if the gain exceeds the reporting threshold set
- 8 by Section 254.031(a)(9) of the Election Code and amended by Commission Rule 18.31 (relating
- 9 to Adjustments to Reporting Thresholds).
- (d) The value of a virtual currency contribution is the fair market value of the virtual currency
  upon receipt.
- 12 (e) A candidate, officeholder, political committee, or caucus who accepts virtual currency
- 13 <u>contributions has the obligation to determine the legality of the virtual currency contributions.</u>
- 14 For a virtual currency contribution to be legal and eligible, a candidate, officeholder, political
- 15 <u>committee, or caucus must obtain the following information before accepting the contribution:</u>
- 16 (1) <u>The contributor's full name;</u>
- 17 (2) <u>The contributor's physical address;</u>
- 18 (3) <u>The contributor's current employer;</u>
- (4) <u>An affirmation that the contributor is in-fact the owner of the virtual currency being</u>
  <u>donated;</u>
- (5) <u>An affirmation that the contributor is not a foreign national who has not been granted</u>
  permanent residence in the United States; and
